Fireworks!

As you plan your Fourth of July festivities, check out the calendar of events at **www.funlake.com/events** and take advantage of the many professional fireworks displays around the Lake area.

Please keep these important tips in mind as you enjoy a Safe and Happy July 4th holiday!

- The POA considers fireworks a nuisance, which is a violation of the Declaration of Restrictive Covenants.
- The Village of Four Seasons has a Fireworks Ordinance which states: *No Fireworks Allowed in the Village of Four Seasons* (per Chapter 18.19).
- The Sunrise Beach Fire Department states that residential fireworks must be 1.4g or less.
- The City of Lake Ozark prohibits fireworks usage in residential areas.
- The City of Osage Beach prohibits the use of fireworks at residences within the city limits. Large professional displays, sponsored by professional companies, must obtain a permit 7 days before the display. Likewise, the Osage Beach Fire Dept. prohibits fireworks within the Osage Beach city limits.


"And a Great Time was Had By All"

One Appointed Director Position From Shawnee Bend For Four Seasons Lakesites Property Owners Association, Inc. ____



Qualifications: Any candidate for a Director's position must be a member in good standing of the Association by;

- a. Being current on all financial obligations to the Association.
- b. Not being a party to any legal action in which the Association is in an adversarial position to the candidate.
- c. Signing "Fiduciary Duties and Code of Conduct" statements that the candidate understands the responsibility and authority of a Director and to identify any possible conflicts of interest.
- d. The appointed position for this Director position must be from the Porto Cima neighborhoods on Shawnee Bend.

Board Directors must be able to commit the time necessary to responsibly fulfill their commitment to the organization. This includes: board training, analyzing financial statements, preparing budgets, being able to attend monthly work sessions and monthly meetings, participating in special meetings and working as a liaison for one or more volunteer committees. There is also a substantial amount of time invested in reviewing documents, visiting and reviewing on-site situations, attending social events and being prepared to assist in any other capacity required.

While daylight hours and temperatures peak, the ACC understands performing work early in the morning and later in the evening is tempting but, we must remind Owners that work should not commence prior to 7:00 a.m. nor continue past 7:00 p.m. Construction work is prohibited on Sundays and Holidays, unless special permission by the ACC is obtained.

The ACC would also like to remind everyone that now is the perfect time to keep an eye out for trees that may be dead or diseased. Permits are required to remove any trees over 6-inches in diameter, whether they are dead or alive. There is no charge for a tree removal permit. Please contact the administrative staff at

Wastewater System Reminder

Summer has finally arrived, and many Four Seasons property owners are using their lake homes more frequently, making it a good time to remind homeowners of items that should not be put into your wastewater treatment system. Please remember to **never allow any of the following items to enter your system:**

Baby Wipes • Cat Litter • Cigarette Butts • Coffee Grounds
Dental Floss • Disposable Diapers • Dryer Sheets • Ear Plugs • Fat
Gasoline • Grease • Insect or Weed Killers • Lint • Mop Strings
Motor Oil • Oils of any kind • Paper Towels • Paints & Thinners
Photographic Chemicals • Plastic Products • Rag & Scouring Pads
Rubber Products • Sanitary Napkins • Solvents • Tampons
Toothbrushes • Towels & Washcloths

All of these items can have a detrimental effect on the operating condition of your system. Your treatment system, including those homes that utilize grinder pump stations, will handle all wastewater from your home and all items that are commonly disposed of by your plumbing system. However, by making sure that none of these items enter your system, you will decrease the risk of damaging it, possibly resulting in a costly repair bill.
