Storage Facilities

As many of you know, the POA offers fenced in secured storage for trailers, campers, etc. on Horseshoe Bend as well as in Porto Cima. These two storage facilities are at full capacity with a lengthy waiting list. To better serve all members of the POA, please alert Management if you are no longer in need of your space so that we may reach out to those who are patiently awaiting a spot to store their item.

Spaces are assigned to specific tenants so that we may maintain an inventory system to ensure all tenants have a space to park their storage item. There have been some issues with persons parking in the incorrect space, therefore, signs are hung with the tenant's space number so it is easier to remember exactly where to park. Please also remember that the trailer should be lined up in the middle of the space number sign to allow adequate space for all trailers to come and go safely.

Friendly Reminders

With the Community growing so rapidly in the last few years, we would like to take this oppourtunity to go over a few points of importance.

<u>Trailers and RV's:</u> Parking trailers and RV's is not allowed on your property. If you need to have your trailer or RV on your property, you must call the Office to receive permission (up to 72 hours). If you need longer, there is an overflow parking area available on a first-come-first-serve basis.

<u>Trash Cans and Enclosures:</u> Must be kept clean and orderly, since wild animals love trash and make a mess. Please secure your trash can and make sure the can fits in your enclosure. If you need a larger enclosure, please call the Office to obtain a permit. There is no cost for this permit.

<u>Parking and Traffic:</u> Please be courteous to others. Do not block driveways and if you have to park on the road please pull over as far as possible.

Boat Launches: The launches cannot be used by any commercial business. They are for property owners in good standing only. Please be respectful to others if you are using one of the launches. Contact Owners Services if you see anything unapproved.

<u>Pets and Waste:</u> All pets must be kept under control. Please make sure your pets are not running at large and being destructive. You could receive a fine if your dog is running loose. Keep in mind that there is no animal control on weekends to assist if you lose your dog. Be sure to have proper tags with contact information on your pets. Also, please pick up and properly dispose of any waste from your pet.

<u>Amenities:</u> A big benefit of living in the POA is use of the amenities. To keep them nice for everyone, please be familiar with the rules and treat the amenities like they are your own. If you see any issues, please text or call Owners Services at: 573-434-0021, so we can address the issue immediately.

2024-2025 Managed Deer Hunt

Please make note, Deer Season begins **September 15th and runs thru November 15th**, then continues **November 27th, 2024 thru January 15th, 2025**.

During this time bow hunting is allowed on the Four Seasons POA specified common land. All Hunters will be issued a pink or blue tag to display on the dashboard of their vehicle to indicate they have permission to hunt. Also, bow hunting is allowed on unimproved lots with owner permission AND providing the guidelines and standards of safe hunting practices are followed.

ACC Update

REPLATS: In an effort to avoid complications with assessments, effective immediately, the deadline to apply to combine lots will be September 30th.

No applications will be accepted from October 1st through, and including, December 31st of each year.

Applications that are incomplete as of October 1st will be returned to the owner of the lots and will need to be resubmitted after the first of the year.

A complete application includes the survey (signed by all required signees), the title report, the completed application or applications and all necessary fees.

LEAF REMOVAL: As we come into the Fall and our trees shed their leaves, please remember the following; Per Ameren MO, leaves should not be blown into or dumped into the lake, nor should they be burned on the shoreline. Environmentally, this is detrimental to the lake and lake life.

Horseshoe Bend Special Road District would prefer that any leaves blown into their road ditches be burned. Please remember to make certain that any leaves that are burned in the ditches are far enough away from the pavement to prevent damage.

Anyone that wishes to burn their leaves or other yard waste must check with their local fire protection district to ensure that it is safe to burn that day. Burn Permits from the Sunrise Beach Fire Protection District can be obtained on their website sbfpd.org. The Lake Ozark Fire Protection District burn permit can be obtained on their website lofpd.com. Fires must be attended at all times AND fully extinguished prior to leaving the burn site.

Post Season On-Site Wastewater Treatment System Reminder

Now that summer has come to an end, we want to remind those Four Seasons homeowners that have onsite aerated wastewater treatment systems, to **leave your aerator motor running.** This applies to all homeowners that have onsite aerated wastewater treatment systems; including those that will be winterizing their homes. Your aerator motor is designed to run continuously and will have a longer lifespan if it is left running versus turning it off throughout the winter. There are two reasons for this, the first is that the inside of your treatment tank is a highly corrosive environment that can be very hard on the motor. This is especially true if it is left to sit without running all winter. The second reason that you should leave your aerator motor running continuously during the winter is because of the cold temperatures experienced in the area. Cold weather can also be very hard on your aerator motor, if it is allowed to sit without running. Following this one rule, will go a long way in helping to extend the life of your aerator motor.
